1. ON 10/07/1999, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED  
AN ORDER ENJOINING LIQUIDATION OF CERTAIN ENTRIES OF MERCHANDISE  
SUBJECT TO THE ANTIDUMPING DUTY ORDER ON HOT-ROLLED CARBON STEEL  
FLAT PRODUCTS FROM JAPAN EXPORTED BY NIPPON STEEL CORPORATION  
(NSC) AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION.

THIS IS A CORRECTION OF MESSAGE 2273210 ON 09/30/1999 OF  
LIQUIDATION INSTRUCTIONS FOR HOT-ROLLED CARBON STEEL FLAT

PRODUCTS FROM JAPAN (A-588-846) IN PARAGRAPH TWO.

AT THIS TIME, NSC'S INJUNCTION IS STILL IN EFFECT. HOWEVER, ON 09/30/2002, MESSAGE NUMBER 2273210 INSTRUCTED CUSTOMS OFFICERS TO ASSESS ANTIDUMPING DUTIES ON ALL MERCHANDISE (OTHER THAN FIRMS ON A LIST OF EXCEPTIONS) ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION, AT THE CASH DEPOSIT OR BONDING RATE IN EFFECT ON THE DATE OF ENTRY FOR ALL FIRMS. NSC WAS INADVERTENTLY LEFT OFF THE LIST OF COMPANIES NOT TO BE LIQUIDATED. THEREFORE, SINCE NSC'S INJUNCTION, DATED 10/07/1999, REMAINS IN EFFECT, ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE EXPORTED BY NSC AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 06/01/2001 THROUGH 05/31/2002.
