AMENDED CASH DEPOSIT RATE PUBLISHED IN THE FEDERAL REGISTER OF 03/27/2001, IN THE AMENDED FINAL AFFIRMATIVE COUNTERVAILING DUTY DETERMINATION IN ACCORDANCE WITH DECISION UPON REMAND ON CERTAIN CORROSION-RESISTANT CARBON STEEL FLAT PRODUCTS FROM KOREA (C-580-208).
