1. ON NOVEMBER 4, 2002, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A JUDGMENT IN JIANGSU HILONG INTERNATIONAL TRADING CO., LTD V. UNITED STATES (COURT NO. 02-00311) AFFIRMING THE REMAND RESULTS FILED BY THE DEPARTMENT OF COMMERCE ON JULY 26, 2002.

2. IN ACCORDANCE WITH THIS JUDGMENT, UNTIL FURTHER NOTICE, THE REQUIRED CASH DEPOSIT RATE FOR ENTRIES OF SUBJECT MERCHANDISE EXPORTED BY JIANGSU HILONG INTERNATIONAL TRADING COMPANY (JIANGSU HILONG) (A-570-848-034), AND ENTERED, OR WITHDRAWN FROM WAREHOUSE

FOR CONSUMPTION ON OR AFTER APRIL 22, 2002, WILL BE 62.77 PERCENT.

3. IN FURTHER ACCORDANCE WITH THIS JUDGMENT, THE PRELIMINARY INJUNCTION ISSUED BY THE COURT ON JUNE 4, 2002, ENJOINING COMMERCE FROM APPLYING THE CASH DEPOSIT RATE, AS DETERMINED BY COMMERCE IN THE FINAL RESULTS OF THE 1999/2000 ANTIDUMPING DUTY ADMINISTRATIVE REVIEW OF FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA, IS DISSOLVED. SEE MESSAGE NUMBER 2183207, DATED JULY 2, 2002, "PRELIMINARY INJUNCTION ON CRAWFISH FROM CHINA (A-570-848)." HOWEVER, ON JUNE 27, 2002, THE COURT ISSUED A PRELIMINARY INJUNCTION FILED BY THE CRAWFISH PROCESSOR'S ALLIANCE, ENJOINING LIQUIDATION OF CERTAIN ENTRIES OF SUBJECT MERCHANDISE EXPORTED BY JIANGSU HILONG. SEE MESSAGE NUMBER 2203201, DATED JULY 22, 2002. ACCORDINGLY, UNTIL FURTHER NOTICE, CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF SUBJECT MERCHANDISE EXPORTED BY JIANGSU HILONG (A-570-848-034) WHICH WERE ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION DURING THE PERIOD SEPTEMBER 1, 1999 THROUGH AUGUST 31, 2000.
