THE DEPARTMENT OF COMMERCE HAS AMENDED THE PRELIMINARY DETERMINATION OF ITS ANTIDUMPING DUTY INVESTIGATION ON CERTAIN FROZEN FISH FILLETS FROM THE SOCIALIST REPUBLIC OF VIETNAM FOR THE PERIOD OF 10/01/2001 THROUGH 03/31/2002. THIS AMENDMENT WAS PUBLISHED ON MARCH 5, 2003 IN THE FEDERAL REGISTER.

2. THIS CHANGES THE CASH DEPOSIT RATE FOR 1) AN GIANG FISHERIES IMPORT EXPORT JOINT STOCK COMPANY ("AGIFISH"), AN GIANG

AGRICULTURE AND FOOD IMPORT EXPORT COMPANY ("AFIEX"), CAN THO ANIMAL FISHERY PRODUCTS PROCESSING EXPORT ENTERPRISE ("CAFATEX"), DA NANG SEAPRODUCTS IMPORT-EXPORT CORPORATION ("DA NANG"), MEKONG FISH COMPANY ("MEKONIMEX"), QVD COMPANY LIMITED ("QVD"), VIET HAI SEAFOOD COMPANY LIMITED ("VIET HAI"). FOR SHIPMENTS OF CERTAIN FROZEN FISH FILLETS FROM THE SOCIALIST REPUBLIC OF VIETNAM ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JANUARY 31, 2003, THE AMENDED CASH DEPOSIT REQUIREMENT IS AS FOLLOWS:

CUSTOMS SHOULD APPLY THE AFIEX MARGIN PERCENTAGE TO ENTRIES MADE BY A. SEAFOOD INDUSTRY. SIMILARLY, CUSTOMS SHOULD APPLY THE VIET HAI MARGIN PERCENTAGE TO ANY ENTRIES MADE BY VIETNAM FISH ONE COMPANY LIMITED.

3. THESE CASH DEPOSITS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL DETERMINATION.

4. PLEASE NOTE THAT THERE IS NO CHANGE TO THE CASH DEPOSIT RATE FOR CAN THO AGRICULTURAL AND ANIMAL PRODUCTS IMPORT EXPORT COMPANY, A-552-801-004 ("CATACO"), VINH HOAN COMPANY LIMITED, A-552-801-002 ("VINH HOAN"), AND THE ALL-OTHER VIETNAM-WIDE RATE, A-552-801-000 . PLEASE CONTINUE TO USE THE CASH DEPOSIT RATE FOUND IN EMAIL 3034201, FEBRUARY 3, 2003 FOR THOSE THREE ENTITIES.

5. DO NOT LIQUIDATE ANY ENTRIES OF THE MERCHANDISE INCLUDED IN THIS ANTIDUMPING DUTY INVESTIGATION UNTIL APPRAISEMENT INSTRUCTIONS ARE RECEIVED.

6.
