1. ON 02/20/2003, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED AN INJUNCTION (CONSOL. COURT NO. 98-07-02526) ENJOINING LIQUIDATION, DURING THE PENDENCY OF LITIGATION IN THE COURT OF APPEALS FOR THE FEDERAL CIRCUIT, OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDERS ON ANTIFRICTION BEARINGS (A-412-201-010 AND A-412-203-010) FROM THE UNITED KINGDOM, MANUFACTURED OR EXPORTED BY RHP BEARINGS LTD. AND NSK BEARINGS EUROPE LTD., FOR THE PERIOD 05/01/1996 THROUGH 04/30/1997 WHICH REMAIN UNLIQUIDATED AT THE CLOSE OF BUSINESS ON 02/27/2003. THE COURT NUMBER IS 98-07-02526.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED OR EXPORTED BY RHP BEARINGS LTD. OR NSK BEARINGS EUROPE LTD., OR IMPORTED INTO THE UNITED STATES BY ITS U.S. SUBSIDIARIES, AFFILIATES, AND ANY PARTIES RELATED THEREOF, AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/1996 THROUGH 04/30/1997 AND WHICH REMAIN UNLIQUIDATED AT THE CLOSE OF BUSINESS ON 02/27/2003. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
