THE DEPARTMENT OF COMMERCE COMPLETED THE ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON CERTAIN APPAREL FROM ARGENTINA (C-357-404) FOR THE PERIOD JANUARY 1, 1989 THROUGH DECEMBER 31, 1989, AND PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON AUGUST 23, 1991 (AMENDED ON OCTOBER 9, 1991).
2. AS A RESULT OF OUR REVIEW, WE DETERMINE THE TOTAL BOUNTY OR GRANT TO BE ZERO OR DE MINIMIS FOR THE FOUR FIRMS,

ALPARGATUS, MERCHANT EXPORT, ALGODONERA SANTA FE, AND FBM AND 1.96 PERCENT AD VALOREM FOR ALL OTHER FIRMS DURING THE PERIOD.

3. FOR PURPOSES OF THESE INSTRUCTIONS THE SUBJECT MERCHANDISE IS CLASSIFIABLE UNDER THE FOLLOWING HTS ITEM NUMBERS:

4. THEREFORE, YOU ARE TO ASSESS COUNTERVAILING DUTIES AT THE NOTED RATES ON MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1989 AND ON OR BEFORE DECEMBER 31, 1989:

5. THE SUSPENSION OF LIQUIDATION ORDERED FOR SHIPMENTS OF THIS MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1989 AND ON OR

BEFORE DECEMBER 31, 1989 IS LIFTED. LIQUIDATION INSTRUCTIONS FOR THE 1990 PERIOD WERE PREVIOUSLY ISSUED IN E-MAIL #3039113 DATED FEBRUARY 8, 1993. THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF THIS MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1991 WILL CONTINUE.

6. THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT REQUIRE THAT INTEREST BE PAID ON OVERPAYMENTS OR UNDERPAYMENTS OF AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. SUCH INTEREST IS PAYABLE AT THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD. THE INTEREST SHALL BE CALCULATED AT THAT RATE FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION.
