1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (68 FR 6878) ON 02/11/03 THE FINAL RESULTS OF ITS THIRD ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT

TO THE ANTIDUMPING ORDER ON FRESH ATLANTIC SALMON FROM CHILE FOR THE PERIOD 07/01/2000 THROUGH 06/30/2001.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR

SHIPMENTS OF FRESH ATLANTIC SALMON FROM CHILE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 08/13/2001, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
