1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER 68 FR 14193 ON 03/24/2003 THE AMENDED FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON STAINLESS STEEL SHEET AND STRIP IN COILS FROM GERMANY FOR THE PERIOD 07/01/2000 THROUGH 06/30/2001.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS.

THEREFORE, FOR SHIPMENTS OF STAINLESS STEEL SHEET AND STRIP IN COILS FROM GERMANY ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 03/24/2003, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

THYSSENKRUPP NIROSTA GMBH A-428-825-001 4.74

3. THE DEPARTMENT OF COMMERCE HAS FOUND THAT THYSSENKRUPP VDM GMBH, A THYSSENKRUPP NIROSTA GMBH AFFILIATE, EXPORTS SUBJECT MERCHANDISE. THEREFORE, ALL SHIPMENTS OF STAINLESS STEEL SHEET AND STRIP IN COILS FROM GERMANY EXPORTED BY THYSSENKRUPP VDM GMBH

WILL REQUIRE THE SAME CASH DEPOSIT AS THYSSENKRUPP NIROSTA GMBH.

4. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

B. IF THE EXPORTER OF THE SUBJECT MERCHANDISE DOES NOT HAVE ITS OWN RATE, BUT THE MANUFACTURER HAS ITS OWN RATE, THE CASH DEPOSIT RATE WILL BE THE MANUFACTURER'S RATE.

C. WHERE NEITHER THE EXPORTER NOR THE MANUFACTURER CURRENTLY HAS ITS OWN RATE OR THE MANUFACTURER IS UNKNOWN, USE THE 'ALL OTHER' RATE FOR ESTABLISHING THE CASH DEPOSIT RATE.

5. FOR ALL MANUFACTURERS/EXPORTERS OF STAINLESS STEEL SHEET AND STRIP IN COILS FROM GERMANY WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 13.48 PERCENT.

6. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.

7.
