THE U.S. COURT OF INTERNATIONAL TRADE HAS ISSUED A PRELIMINARY INJUNCTION ENJOINING THE LIQUIDATION OF CERTAIN AFB ENTRIES DURING THE PERIOD MAY 1, 1990 THROUGH APRIL 30, 1991, SUBJECT TO THE ANTIDUMPING DUTY ORDERS ON ANTFRICTION BEARINGS (AFBS) (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM GERMANY, AND EXPORTED OR MANUFACTURED BY THE COMPANIES LISTED BELOW.

2. THE CLASSES OR KINDS COVERED BY THE INJUNCTION ARE INDICATED

WITHIN PARENTHESES NEXT TO THE FIRM'S NAME.

3. UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF ANTI-FRICTION BEARINGS (AFBS) (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM GERMANY THAT WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD MAY 1, 1990 THROUGH APRIL 30, 1991 AND THAT WERE PRODUCED OR EXPORTED BY THE FOLLOWING FIRMS, UNLESS EXPORTED BY AN UNLISTED OEM:

FAG (ALL CLASSES)

GMN (BALL BEARINGS ONLY)

INA (BALL BEARINGS AND CYLINDRICAL ROLLER BEARINGS)

NTN - FRG (BALL BEARINGS ONLY)

SKF - FRG (ALL CLASSES)

4. WITH RESPECT TO ENTRIES OF REVIEWED FIRMS NOT COVERED BY AN INJUNCTION, APPRAISEMENT INSTRUCTIONS HAVE ALREADY BEEN ISSUED, OR WILL BE FORTHCOMING. IF YOU HAVE NOT YET RECEIVED APPRAISEMENT INSTRUCTIONS FOR THESE ENTRIES, CONTINUE TO SUSPEND LIQUIDATION UNTIL SPECIFIC APPRAISEMENT INSTRUCTIONS ARE ISSUED.
