THE PERIOD 10/01/1998 THROUGH 09/30/1999. THIS MESSAGE CLARIFIES THAT SUSPENSION OF LIQUIDATION SHOULD BE LIFTED FOR THESE ENTRIES AS A CONSEQUENCE OF THE U.S. COURT OF INTERNATIONAL TRADE'S AFFIRMATION OF THE DEPARTMENT OF COMMERCE'S FINAL RESULTS(SLIP
