THIS IS TO AMEND OUR ORIGINAL INSTRUCTIONS (MESSAGE NO. 3332113) DATED NOVEMBER 27, 1992, REGARDING THE LIQUIDATION OF ENTRIES OF ITALIAN BALL BEARINGS AND CYLINDRICAL ROLLER BEARINGS EXPORTED BY AEROSPATIALE DIVISION HELICOPTERS, AND ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION BY AEROSPATIALE HELICOPTER CORPORATION DURING THE PERIOD MAY 1, 1990 THROUGH APRIL 30, 1991.

2. FOR ALL SHIPMENTS OF ITALIAN BALL BEARINGS EXPORTED BY

AEROSPATIALE DIVISION HELICOPTERS, AND ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION BY AEROSPATIALE HELICOPTER CORPORATION DURING THE PERIOD MAY 1, 1990 THROUGH APRIL 30, 1991, REVISE THE DUMPING LIABILITY TO EQUAL .13 PERCENT OF THE PER-UNIT ENTERED CUSTOMS VALUE.

3. FOR ALL SHIPMENTS OF ITALIAN CYLINDRICAL ROLLER BEARINGS EXPORTED BY AEROSPATIALE DIVISION HELICOPTERS, AND ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION BY AEROSPATIALE HELICOPTER CORPORATION DURING THE PERIOD MAY 1, 1990 THROUGH APRIL 30, 1991, REVISE THE DUMPING LIABILITY TO EQUAL 5.03 PERCENT OF THE PER-UNIT ENTERED CUSTOMS VALUE.
