RE: SCOPE RULING ON SHOP TOWELS OF COTTON FROM THE
PEOPLE'S REPUBLIC OF CHINA - VENUS

1. ON FEBRUARY 19, 1993, IN RESPONSE TO A REQUEST BY VENUS TEXTILES, INC. (VENUS), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT CERTAIN TOWELS THAT VENUS INTENDS TO IMPORT ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING SHOP TOWELS OF COTTON FROM THE PEOPLE'S REPUBLIC OF CHINA.

2. THE DEPARTMENT DETERMINED THAT CERTAIN TOWELS THAT VENUS INTENDS TO IMPORT, WHICH ARE 18" X 30" IN SIZE, MADE OF

CHINESE COTTON OSNABURG FABRIC (A LOOSELY WOVEN FABRIC OF PLAIN WEAVE), CONTAINING A YARN TYPE OF NUMBER 10 (10S), AND HAVING A YARN COUNT CONSTRUCTION OF 29 X 29 (A YARN COUNT OF 29 THREADS PER INCHES IN WARP AND 29 IN THE FILLING), FALL WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING SHOP TOWELS OF COTTON FROM THE PEOPLE'S REPUBLIC OF CHINA.

3. CONTINUE TO SUSPEND LIQUIDATION OF SHOP TOWELS OF COTTON, INCLUDING VENUS TOWELS LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING SHOP TOWELS OF COTTON FROM THE PEOPLE'S REPUBLIC OF CHINA.
