PEOPLE'S REPUBLIC OF CHINA. AS A RESULT OF THIS DETERMINATION, WE FIND SUZHOU SANJIAN NUTRIENT AND HEALTH PRODUCTS CO., LTD. ("SUZHOU HEALTH PRODUCTS") TO BE THE SUCCESSOR-IN-INTEREST TO SUZHOU SANJIAN FINE CHEMICAL CO. LTD. ("SUZHOU CHEMICAL")(A-570-852-005).

2. ACCORDINGLY, SHIPMENTS BY SUZHOU HEALTH PRODUCTS OF CREATINE
