1. THIS MESSAGE IS A CORRECTION TO MESSAGE NO. 3099204 DATED APRIL 9, 2003, WHICH INSTRUCTED YOU TO ASSESS ANTIDUMPING DUTIES ON BALL BEARINGS AND PARTS THEREOF (BBS) FROM THE UNITED KINGDOM PRODUCED AND EXPORTED BY NSK/RHP AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/2001 THROUGH 04/30/2002.

2. ON AUGUST 1, 2002, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH: A) WERE PRODUCED BY NSK/RHP AND ITS AFFILIATES; B) WERE EXPORTED FROM THE UNITED KINGDOM DURING THE PERIOD 05/01/2001, THROUGH 04/30/2002; AND C) ARE SUBJECT TO THE ANTIDUMPING ORDER ON BALL BEARINGS AND PARTS THEREOF FROM THE UNITED KINGDOM.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED AND EXPORTED TO THE UNITED STATES BY NSK/RHP, AND ANY PARTIES RELATED THERETO, AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/2001 THROUGH 04/30/2002. ANY SUCH ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
