1. THIS INSTRUCTION AMENDS PARAGRAPH 2 OF MESSAGE NUMBER 2162202 DATED 06/11/2002. THAT MESSAGE PROVIDED INSTRUCTIONS FOR CERTAIN EXPORTERS PARTICIPATING IN THE NEW SHIPPER REVIEW OF THE ANTIDUMPING DUTY ORDER ON BRAKE ROTORS FROM THE PEOPLE'S REPUBLIC

OF CHINA (PRC), FOR THE PERIOD 04/01/2001 THROUGH 03/31/2002. PARAGRAPH 2 OF THAT MESSAGE SHOULD BE REPLACED WITH THE FOLLOWING:

FOR SHIPMENTS OF BRAKE ROTORS FROM THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION IN THE UNITED STATES AFTER APRIL 3, 2003, A BOND OR CASH DEPOSIT OF 43.32 PERCENT IS PERMITTED, AT THE IMPORTER'S OPTION, FOR THE FOLLOWING COMBINATIONS OF EXPORTERS AND MANUFACTURERS:

2. THE EFFECTIVE DATE OF THESE AMENDED CASH DEPOSIT INSTRUCTIONS IS APRIL 3, 2003.
