RE: LIQUIDATION INSTRUCTIONS FOR THE COUNTERVAILING DUTY ORDER ON ACETYLSALICYLIC ACID (ASPIRIN) FROM TURKEY AND REVOCATION

1. THE DEPARTMENT OF COMMERCE DID NOT RECEIVE A REQUEST FOR ADMINISTRATIVE REVIEW FOR THE COUNTERVAILING DUTY ORDER ON ACETYLSALICYLIC ACID (ASPIRIN) FROM TURKEY (C-489-603) FOR THE PERIOD JANUARY 1, 1991 THROUGH DECEMBER 31, 1991. IN ADDITION, ON JANUARY 27, 1993, THE DEPARTMENT REVOKED THIS COUNTERVAILING DUTY ORDER, WITH EFFECT FOR ALL SHIPMENTS OF THE SUBJECT MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1992.

2. THE MERCHANDISE COVERED BY THESE INSTRUCTIONS ARE SHIPMENTS

OF ACETYLSALICYLIC ACID (ASPIRIN), CONTAINING NO ADDITIVES OTHER THAN INACTIVE SUBSTANCES (SUCH AS STARCH, LACTOSE, CELLULOSE, OR COLORING MATERIAL), AND/OR ACTIVE SUBSTANCES IN CONCENTRATIONS LESS THAN SPECIFIED FOR PARTICULAR NON-PRESCRIPTION DRUG COMBINATIONS OF ASPIRIN AND ACTIVE SUBSTANCES AS PUBLISHED IN THE HANDBOOK OF NON-PRESCRIPTION DRUGS, EIGHTH EDITION, AMERICAN PHARMACEUTICAL ASSOCIATION, AND NOT IN TABLET, CAPSULE OR SIMILAR FORMS FOR DIRECT HUMAN CONSUMPTION, FROM TURKEY. THIS PRODUCT IS CURRENTLY CLASSIFIED UNDER ITEM 2918.22 OF THE HARMONIZED TARIFF SCHEDULES OF THE UNITED STATES.

3. IN ACCORDANCE WITH SECTION 355.22(G) OF THE COMMERCE REGULATIONS, YOU ARE TO ASSESS COUNTERVAILING DUTIES AT RATES EQUAL TO THE CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES REQUIRED AT THE TIME OF ENTRY ON MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1991 AND ON OR BEFORE DECEMBER 31, 1991:

4. FOR ALL SHIPMENTS EXPORTED FROM TURKEY ON OR AFTER JANUARY 1, 1992, YOU ARE TO LIQUIDATE, WITHOUT REGARD TO COUNTERVAILING DUTIES, ALL UNLIQUIDATED ENTRIES OF THIS MERCHANDISE.

5. IN ACCORDANCE WITH SECTION 355.25(d)(5) OF THE DEPARTMENT'S REGULATIONS, THE SUSPENSION OF LIQUIDATION IS TERMINATED FOR THIS MERCHANDISE.

6. THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT REQUIRE THAT INTEREST BE PAID ON OVERPAYMENTS OR UNDERPAYMENTS OF AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. SUCH INTEREST

IS PAYABLE AT THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD. THE INTEREST SHALL BE CALCULATED AT THAT RATE FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION.
