1. THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER
OF APRIL 30, 1993, THE AMENDMENT TO ITS NOTICE OF FINAL
RESULTS OF ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY
ORDER ON LIVE SWINE FROM CANADA (C-122-404). THE REVIEW
COVERS THE PERIOD APRIL 1, 1988 THROUGH MARCH 31, 1989.

2. IMPORTS COVERED BY THE REVIEW ARE SHIPMENTS OF LIVE SWINE
FROM CANADA. THROUGH 1988, SUCH MERCHANDISE WAS CLASSIFIABLE
UNDER ITEM NUMBER 100.8500 OF THE TARIFF SCHEDULES OF THE

UNITED STATES ANNOTATED, AND IS CURRENTLY CLASSIFIABLE UNDER ITEM NUMBERS 0103.91.00 AND 0103.92.00 OF THE HARMONIZED TARIFF SCHEDULE.

3. THE NET SUBSIDY FOR SLAUGHTER SOWS AND BOARS IS CANADIAN \$0.0040 PER POUND; CANADIAN \$0.0005 PER POUND FOR WEANLINGS; AND CANADIAN \$0.0051 PER POUND FOR ALL OTHER LIVE SWINE FOR THE PERIOD APRIL 1, 1988 THROUGH MARCH 31, 1989.
4. ACCORDINGLY, YOU ARE TO ASSESS COUNTERVAILING DUTIES AS NOTED ABOVE ON ALL SHIPMENTS OF THIS MERCHANDISE EXPORTED ON OR AFTER APRIL 1, 1988 AND ON OR BEFORE MARCH 31, 1989.
5. THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT REQUIRE THAT INTEREST BE PAID ON OVERPAYMENTS OR UNDERPAYMENTS OF AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. SUCH INTEREST IS PAYABLE AT THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD. THE INTEREST SHALL BE CALCULATED AT THAT RATE FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION.
6. THE SUSPENSION OF LIQUIDATION ORDERED FOR THIS MERCHANDISE EXPORTED ON OR BEFORE MARCH 31, 1989 IS LIFTED. SUSPENSION OF LIQUIDATION FOR ALL ENTRIES OF THIS MERCHANDISE EXPORTED ON OR AFTER APRIL 1, 1989 WILL CONTINUE.
7. CUSTOMS OFFICERS WILL CONTINUE TO COLLECT A CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES OF CAN\$0.0049 PER POUND FOR SLAUGHTER SOWS AND BOARS AND CAN\$0.0932 FOR ALL OTHER LIVE SWINE.
