CORPORATION AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE,

FOR CONSUMPTION DURING THE PERIOD 07/01/1999 THROUGH 06/30/2000.
CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL
LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE
SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
