PENDING THE CONVERSION OF THE SCOPE OF THE ORDER ON CERTAIN TEXTILE MILL PRODUCTS FROM ARGENTINA, HOWEVER, THE DEPARTMENT IS NOT LIQUIDATING ENTRIES OF MERCHANDISE SUBJECT TO THIS ORDER MADE AFTER NOVEMBER 8, 1992.

THE SUBJECT MERCHANDISE ARE SHIPMENTS OF TEXTILE MILL PRODUCTS FROM ARGENTINA, CURRENTLY CLASSIFIABLE UNDER THE HTS ITEM NUMBERS LISTED IN CIE #N-208/84 (FEB 22, 1989, SUPPL. 41).

FOR CERTAIN TEXTILE MILL PRODUCTS FROM ARGENTINA, MERCHANDISE EXPORTED AFTER NOVEMBER 8, 1992 SHOULD NOT BE LIQUIDATED.

WITH THE EXCEPTION OF CERTAIN TEXTILE MILL PRODUCTS FROM ARGENTINA, THE SUSPENSION OF LIQUIDATION ORDERED FOR THE ABOVE MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1992 AND ON OR BEFORE DECEMBER 31, 1992 IS LIFTED. THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF THIS MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1993 WILL CONTINUE. THE SUSPENSION OF LIQUIDATION ORDERED FOR CERTAIN TEXTILE MILL PRODUCTS FROM ARGENTINA EXPORTED ON OR AFTER JANUARY 1, 1992 AND ON OR BEFORE NOVEMBER 8, 1992 IS LIFTED. LIQUIDATION FOR ALL SHIPMENTS OF ARGENTINE TEXTILE MILL PRODUCTS EXPORTED ON OR AFTER NOVEMBER 9, 1992 WILL CONTINUE.

6. THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT REQUIRE THAT INTEREST BE PAID ON OVERPAYMENTS OR UNDERPAYMENTS OF AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. SUCH INTEREST IS PAYABLE AT THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD. THE INTEREST SHALL BE CALCULATED AT THAT RATE FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION.
