(A-570-848-038) FOR THE PERIOD 09/01/2001 THROUGH 08/31/2002.

2. AS A RESULT OF COMMERCE'S RESCISSION, FOR THE FOLLOWING PRODUCER AND EXPORTER IDENTIFIED BELOW, IN THE COMBINATION
