1. ON MAY 29, 2003, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER (68 FR 32013) ITS INITIATIONS OF ANTIDUMPING DUTY INVESTIGATIONS OF CERTAIN COLOR TELEVISIONS FROM THE PEOPLE'S REPUBLIC OF CHINA, AND MALAYSIA.

2. FOR PURPOSES OF THESE INVESTIGATIONS, THE TERM "CERTAIN COLOR TELEVISION RECEIVERS" INCLUDES COMPLETE AND INCOMPLETE DIRECT-VIEW OR PROJECTION-TYPE CATHODE-RAY TUBE COLOR TELEVISION

RECEIVERS, WITH A VIDEO DISPLAY DIAGONAL EXCEEDING 52 CM, WHETHER OR NOT COMBINED WITH VIDEO RECORDING OR REPRODUCING APPARATUS, WHICH ARE CAPABLE OF RECEIVING A BROADCAST TELEVISION SIGNAL AND PRODUCING A VIDEO IMAGE. SPECIFICALLY EXCLUDED FROM THESE INVESTIGATIONS ARE COMPUTER MONITORS OR OTHER VIDEO DISPLAY DEVICES THAT ARE NOT CAPABLE OF RECEIVING A BROADCAST TELEVISION SIGNAL.

THE COLOR TELEVISION RECEIVERS SUBJECT TO THESE INVESTIGATIONS ARE CURRENTLY CLASSIFIABLE UNDER SUBHEADINGS 8528.12.2800, 8528.12.3250, 8528.12.3290, 8528.12.3600, 8528.12.4000, 8528.12.4400, 8528.12.4800, 8528.12.5200, AND 8528.12.5600 OF THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES ("HTSUS"). ALTHOUGH THE HTSUS SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, THE WRITTEN DESCRIPTION OF THE SCOPE OF THE MERCHANDISE UNDER INVESTIGATION IS DISPOSITIVE.
