(A-570-848-014)

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS MANUFACTURED OR EXPORTED BY

QINGDAO RIRONG FOODSTUFF CO., LTD., CURRENTLY CLASSIFIED UNDER HTS SUBHEADINGS: 1605.40.10.10, 1605.40.10.90, 0306.19.00.10 OR 0306.29.00.00, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD SEPTEMBER 1, 2000 THROUGH AUGUST 31, 2001. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
