ON SEPTEMBER 8, 1998, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES OF BALL BEARINGS AND PARTS THEREOF (A-412-201) FROM THE UNITED KINGDOM, EXPORTED OR IMPORTED BY THE BARDEN CORPORATION (U.K.) LTD., THE BARDEN CORPORATION, FAG BEARINGS CORPORATION, THEIR U.S. SUBSIDIARIES AND AFFILIATES, AND ANY PARTIES RELATED THERETO, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD MAY 1, 1995, THROUGH APRIL

30, 1996. THE CIT COURT NUMBER IS 97-11-01983. THE DEPARTMENT OF COMMERCE HAS NOT ISSUED LIQUIDATION INSTRUCTIONS FOR THIS PERIOD AND THESE COMPANIES.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE EXPORTED OR IMPORTED BY THE BARDEN CORPORATION (U.K.) LTD., THE BARDEN CORPORATION, FAG BEARINGS CORPORATION, THEIR U.S. SUBSIDIARIES AND AFFILIATES, AND ANY PARTIES RELATED THERETO, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD MAY 1, 1995, THROUGH APRIL 30, 1996. UNLESS OTHERWISE INSTRUCTED, CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES OF THE ABOVE-DESCRIBED MERCHANDISE WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
