TO THE ANTIDUMPING ORDER ON CERTAIN CASED PENCILS FROM THE PEOPLE'

S REPUBLIC OF CHINA FOR THE PERIOD 12/01/2000 THROUGH 11/30/2001.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE
