RE: Antidumping duty scope determination on wooden bedroom furniture from the People's Republic of China (A-570-890)

Notice of the lifting of suspension occurred on the message date of these instructions. See paragraph 5 below.

1. Commerce received a scope ruling request from Badger Basket Company ("Badger Basket"). Commerce issued a final scope determination on 04/02/2013 that Badger Basket's wooden infant changing table with one hamper and three baskets (model numbers 02400, 02401, 02402, 02403, 02404, and 02405) ("infant changing table") which Badger Basket imports is not within the scope of the antidumping duty order on wooden bedroom furniture from the People's Republic of China (A-570-890).
2. Commerce determined that Badger Basket's infant changing table is outside the scope of the order because the infant changing table is sufficiently distinguishable from dressers and other wooden bedroom furniture explicitly listed in the scope of the WBF Order. Therefore, Badger Basket's infant changing table is not within the scope of the antidumping duty order on wooden bedroom furniture from the People's Republic of China.
3. For all entries of the infant changing table that remain unliquidated on or after 06/24/2004, CBP shall terminate suspension and liquidate entries of the infant changing table which were entered, or withdrawn from warehouse, for consumption.
4. Refund any cash deposits and release any bonds relating to the infant changing table described above.
5. These instructions constitute notice of the lifting of suspension of liquidation of entries of the infant changing table entered, or withdrawn from warehouse, for consumption on or after 06/24/2004.
6. The assessment of antidumping duties by CBP on shipments or entries of this merchandise is subject to the provisions of section 778 of the Tariff Act of 1930, as amended. Section 778

requires that CBP pay interest on overpayments or assess interest on underpayments of the required amounts deposited as estimated antidumping duties. The interest provisions are not applicable to cash or bonds posted as estimated antidumping duties before the date of publication of the antidumping duty order. Interest shall be calculated from the date payment of estimated antidumping duties is required through the date of liquidation. The rate at which such interest is payable is the rate in effect under section 6621 of the Internal Revenue Code of 1954 for such period.

7. Unless instructed otherwise, for all other shipments of wooden bedroom furniture from the People's Republic of China not covered by paragraph 2 above, you shall continue to collect cash deposits of estimated antidumping duties for the merchandise at the current rates.
