INJUNCTION ENJOINING LIQUIDATION OF ENTRIES WHICH ARE SUBJECT
TO THE ANTIDUMPING DUTY ORDER ON INDUSTRIAL BELTS FROM ITALY
AND WHICH WERE ENTERED BY PIRELLI TRASMISSIONI INDUSTRIALI,
S.P.A. OR PIRELLI INDUSTRIAL PRODUCTS CORPORATION
(COLLECTIVELY PIRELLI) FROM JUNE 1, 1992 THROUGH MAY 31, 1993.

2. THEREFORE, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF
SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY PIRELLI

AND WHICH WAS ENTERED FOR CONSUMPTION OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION FROM JUNE 1, 1992 THROUGH MAY 31, 1993, AND WHICH REMAIN UNLIQUIDATED AT THE CLOSE OF BUSINESS ON JULY 30, 1993.
