THE ANTIDUMPING DUTY INVESTIGATIONS OF CERTAIN COLD-ROLLED CARBON STEEL FLAT PRODUCTS FROM VARIOUS COUNTRIES HAVE BEEN TERMINATED BECAUSE OF THE INTERNATIONAL TRADE COMMISSION'S (ITC) FINAL DETERMINATION THAT AN INDUSTRY IN THE UNITED STATES IS NOT MATERIALLY INJURED OR THREATENED WITH MATERIAL INJURY, AND THE ESTABLISHMENT OF AN INDUSTRY IN THE UNITED STATES IS NOT MATERIALLY RETARDED, BY REASON OF IMPORTS OF CERTAIN COLD-ROLLED CARBON STEEL FLAT PRODUCTS FROM VARIOUS COUNTRIES.
