1. THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER ON AUGUST 26, 1993 (58 FR 45097), THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON LAMB MEAT FROM NEW ZEALAND (C-614-503). THE REVIEW COVERS THE PERIOD APRIL 1, 1991 THROUGH MARCH 31, 1992.
2. IMPORTS COVERED BY THE REVIEW ARE SHIPMENTS OF LAMB MEAT, OTHER THAT PREPARED, PRESERVED OR PROCESSED FROM NEW ZEALAND.

3. DURING THE REVIEW PERIOD SUCH MERCHANDISE WAS CLASSIFIABLE UNDER ITEM NUMBERS 0204.10.0000, 0204.22.2000, 0204.23.2000, 0204.30.0000, 0204.42.2000, 0204.43.2000, OF THE HARMONIZED TARIFF SCHEDULE (HTS).
4. ACCORDINGLY, FOR SHIPMENTS OF LAMB MEAT FROM NEW ZEALAND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER AUGUST 26, 1993. YOU SHALL COLLECT CASH DEPOSTS OF ESTIMATED COUNTERVAILING DUTIES AT ZERO PERCENT OF F.O.B. INVOICE PRICE FOR ALL COMPANIES.
5. THESE CASH DEPOSIT REQUIREMENTWS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW. DO NO LIQUIDATE ANY ENTRIES OF THIS MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONSARE RECEIVED.
