ON 09/12/2003, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON LAWN AND GARDEN STEEL FENCE POSTS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-877), MANUFACTURED OR EXPORTED BY HEBEI METALS AND MINERALS IMPORTS AND EXPORT CORPORATION, AND HEBEI WUXIN METALS AND MINERALS TRADING CO. LTD., ON OR AFTER DECEMBER 4, 2002.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY HEBEI METALS AND MINERALS IMPORTS AND EXPORT CORPORATION, AND HEBEI WUXIN METALS AND MINERALS TRADING CO. LTD., WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER DECEMBER 4,

2002. CONTINUE TO SUSPEND LIQUIDATION OF ALL ENTRIES FROM THESE ENTITIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
