RE: Correction of message 4006305, dated 01/06/2014 concerning the countervailing duty scope determination on aluminum extrusions from the People's Republic of China (C-570-968).

1. This is a correction to message 4006305, dated 01/06/2014, to correct paragraphs 3 and 5.
2. Paragraphs 3 and 5 of message 4006305 contain incorrect information about the effective date. Below is the fully corrected message.

Notice of the lifting of suspension occurred on 01/06/2014, the date of message 4006305. See paragraph 7 below.

3. Commerce received a scope ruling request from Traffic Brick Network, LLC ("Traffic Brick"). Commerce issued a final scope determination on 12/03/2013 that event décor kits (specifically, Pipe Kits and Pipe and Drape Kits) which Traffic Brick imports are not within the scope of the countervailing duty order on aluminum extrusions from the People's Republic of China (C-570-968).
4. Commerce determined that Traffic Brick's event décor kits (specifically, Pipe Kits and Pipe and Drape Kits) are outside the scope of the order because they contain at the time of importation all parts necessary to fully assemble at least one complete display structure (i.e., at least 2 upright Gorilla Pipes, 1 horizontal Gorilla Pipe, and 2 weighted steel bases, or a higher number of each component that would allow for the assembly of multiple complete display structures). Therefore, Traffic Brick's event décor kits (specifically, Pipe Kits and Pipe and Drape Kits) are not within the scope of the countervailing duty order on aluminum extrusions from the People's Republic of China.
5. For all entries of aluminum extrusions not within scope that remain unliquidated on or after 09/07/2010, CBP shall terminate suspension and liquidate entries of product not within scope which were entered, or withdrawn from warehouse, for consumption.
6. Refund any cash deposits and release any bonds relating to Traffic Brick's event décor kits (specifically, Pipe Kits and Pipe and Drape Kits) described above.

7. Notice of the lifting of suspension of liquidation of entries of Traffic Brick's event décor kits (specifically, Pipe Kits and Pipe and Drape Kits) entered, or withdrawn from warehouse, for consumption on or after 09/07/2010 occurred on 01/06/2014, the date of message 4006305.

8. The assessment of countervailing duties by CBP on shipments or entries of this merchandise is subject to the provisions of section 778 of the Tariff Act of 1930, as amended. Section 778 requires that CBP pay interest on overpayments or assess interest on underpayments of the required amounts deposited as estimated countervailing duties. The interest provisions are not applicable to cash or bonds posted as estimated countervailing duties before the date of publication of the countervailing duty order. Interest shall be calculated from the date payment of estimated countervailing duties is required through the date of liquidation. The rate at which such interest is payable is the rate in effect under section 6621 of the Internal Revenue Code of 1954 for such period.

9. Unless instructed otherwise, for all other shipments of aluminum extrusions from the People's Republic of China not covered by paragraph 4 above, you shall continue to collect cash deposits of estimated countervailing duties for the merchandise at the current rates.
