ON OCTOBER 14, 2003, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON GLYCINE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-836), EXPORTED BY TIANJIN TIANCHENG PHARMACEUTICAL CO. LTD. (TTPC) FOR THE PERIOD JANUARY 1, 2002 THROUGH FEBRUARY 28, 2002.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF

SUBJECT MERCHANDISE WHICH WAS EXPORTED BY TTPC AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD JANUARY 1, 2002 THROUGH FEBRUARY 28, 2002. ALL OTHER ENTRIES SHOULD BE LIQUIDATED ACCORDING TO MESSAGE NUMBER 2280216 DATED OCTOBER 7, 2002. ANY ENTRIES FROM TTPC WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
