1. THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE  
REVIEW OF THE ANTIDUMPING DUTY ORDER ON COTTON SHOP TOWELS  
FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-003) FOR THE  
OCTOBER 1, 1990 THROUGH SEPTEMBER 30, 1991 PERIOD AND  
PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON  
SEPTEMBER 22, 1992 (57 FR 43695).

2. ACCORDINGLY, FOR SHIPMENTS OF CHINESE COTTON SHOP TOWELS  
ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR

AFTER SEPTEMBER 22, 1992 THAT WERE EXPORTED BY TIANJIN ARTS AND CRAFTS IMPORT AND EXPORT CORPORATION (A-570-003-008), YOU SHALL COLLECT A CASH DEPOSIT OF 72.14 PERCENT. FOR SHIPMENTS OF CHINESE COTTON SHOP TOWELS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER SEPTEMBER 22, 1992 THAT WERE EXPORTED BY CHINATEX (A-570-003-006) OR CHINA NATIONAL ARTS AND CRAFTS IMPORT AND EXPORT CORPORATION (A-570-003-002), YOU SHALL COLLECT A CASH DEPOSIT OF 122.81 PERCENT. FOR OTHER PREVIOUSLY REVIEWED OR INVESTIGATED COMPANIES, THE CASH DEPOSIT RATE WILL BE THAT COMPANY'S RATE PROVIDED IN THE AD-CVD MODULE. FOR SHIPMENTS OF CHINESE COTTON SHOP TOWELS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER SEPTEMBER 22, 1992 THAT WERE EXPORTED BY COMPANIES WITHOUT A COMPANY-SPECIFIC RATE, YOU SHALL COLLECT A CASH DEPOSIT OF 122.81 PERCENT.

3. CHINESE COTTON SHOP TOWELS ARE CLASSIFIABLE UNDER ITEM NUMBER 6307.10.2005 OF THE HARMONIZED TARIFF SCHEDULE.

4. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES OF THIS MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE ISSUED. INSTRUCTIONS WILL NOT BE SENT UNTIL AT LEAST 30 DAYS AFTER PUBLICATION OF THE FINAL RESULTS, AND MAY BE DELAYED INDEFINITELY IF AN APPEAL OF THE FINAL RESULTS IS FILED WITH THE COURT OF INTERNATIONAL TRADE.
