RE: DIAMOND SAWBLADES AND PARTS THEREOF FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-900) – ZERO CASH DEPOSIT REQUIRED FOR ENTRIES PRODUCED AND EXPORTED BY THE AT&M ENTITY

1. COMMERCE HAS PARTIALLY REVOKED THE ANTIDUMPING DUTY ORDER ON DIAMOND SAWBLADES AND PARTS THEREOF FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-900) WITH RESPECT TO THE AT&M ENTITY, BUT IS INSTRUCTING CBP TO CONTINUE THE SUSPENSION OF LIQUIDATION OF ENTRIES OF DIAMOND SAWBLADES AND PARTS THEREOF FROM THE PEOPLE'S REPUBLIC OF CHINA PRODUCED AND EXPORTED BY THE AT&M ENTITY AND/OR ANY OF ITS MEMBERS (AS LISTED BELOW) WITH ZERO CASH DEPOSIT, AS SPECIFIED BELOW.

2. ON 03/28/2013, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER THE FINAL RESULTS OF THE SECTION 129 DETERMINATION ON DIAMOND SAWBLADES AND PARTS THEREOF FROM THE PEOPLE'S REPUBLIC OF CHINA (78 FR 18958). AS A RESULT OF THIS DETERMINATION, COMMERCE HAS PARTIALLY REVOKED THE ANTIDUMPING DUTY ORDER ON DIAMOND SAWBLADES AND PARTS THEREOF FROM THE PEOPLE'S REPUBLIC OF CHINA WITH RESPECT TO THE AT&M ENTITY. THE EFFECTIVE DATE OF THE PARTIAL REVOCATION IS 03/22/2013.

3. ALTHOUGH COMMERCE HAS PARTIALLY REVOKED THE ANTIDUMPING DUTY ORDER WITH RESPECT TO THE AT&M ENTITY, IN ACCORDANCE WITH THE PRELIMINARY INJUNCTION ISSUED BY THE COURT OF INTERNATIONAL TRADE ON 03/28/2013 (SEE MESSAGE 3093301, DATED 4/3/2013), UNTIL INSTRUCTED OTHERWISE, CBP IS DIRECTED TO SUSPEND OR CONTINUE TO SUSPEND LIQUIDATION OF ALL ENTRIES OF SUBJECT MERCHANDISE PRODUCED AND/OR EXPORTED BY THE AT&M ENTITY AND/OR ANY OF ITS MEMBERS (AS LISTED BELOW) FROM THE PEOPLE'S REPUBLIC OF CHINA WHICH ARE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 01/23/2009.

4. FOR ENTRIES OF DIAMOND SAWBLADES AND PARTS THEREOF FROM THE PEOPLE'S REPUBLIC OF CHINA PRODUCED AND EXPORTED BY THE AT&M ENTITY AND/OR ANY OF

ITS MEMBERS (AS LISTED BELOW) WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER THE EFFECTIVE DATE OF THE REVOCATION NOTICE, 03/22/2013, CBP IS INSTRUCTED TO CONTINUE THE SUSPENSION OF LIQUIDATION OF SUCH ENTRIES WITHOUT A CASH DEPOSIT. SEE COMMERCE'S NOTICE OF PARTIAL REVOCATION, 78 FR 18958.
