FOR ALL EXPORTS OF SULFUR DYES, INCLUDING SULFUR VAT DYES, FROM THE PEOPLE'S REPUBLIC OF CHINA, THE CUSTOMS SERVICE SHALL SUSPEND LIQUIDATION OF SUCH MERCHANDISE THAT IS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION AND SHALL REQUIRE A CASH DEPOSIT OR POSTING OF A BOND EQUAL TO THE APPROPRIATE ESTIMATED PRELIMINARY MARGIN PERCENTAGES LISTED BELOW.
