1. ALL SHIPMENTS OF ROLLER CHAIN, OTHER THAN BICYCLE, FROM JAPAN EXPORTED BY KAGA INDUSTRIES CO., LTD., OR EXPORTED BY APC CORPORATION AND MANUFACTURED BY KAGA INDUSTRIES CO., LTD., AND SOLD DURING THE REVIEW PERIODS APRIL 1, 1988 THROUGH MARCH 31, 1989 AND APRIL 1, 1989 THROUGH MARCH 31, 1990, SHOULD BE LIQUIDATED FREE OF DUMPING LIABILITY. YOU MAY APPRAISE THESE SHIPMENTS AND LIQUIDATE THESE ENTRIES BY STAMPING EACH INVOICE WITH THE WORDING "NO DUMPING DUTIES DUE".

2. THE ASSESSMENT OF ANTIDUMPING DUTIES BY THE CUSTOMS SERVICE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT, WHICH REQUIRES INTEREST ON OVERPAYMENTS OR UNDERPAYMENTS OF THE AMOUNT DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION.
