ON NOVEMBER 14, 2003, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON HONEY FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-863), EXPORTED TO THE UNITED STATES BY WUHAN BEE HEALTHY CO., LTD. FOR THE PERIOD DECEMBER 1, 2001, THROUGH MAY 31, 2002.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES

OF SUBJECT MERCHANDISE WHICH WAS EXPORTED BY WUHAN BEE HEALTHY CO., LTD. AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 12/01/2001 THROUGH 05/31/2002. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
