1. IN RESPONSE TO AN OCTOBER 22, 1992, REQUEST BY SKADDEN, ARPS, SLATE, MEACHER, AND FLOM, THE DEPARTMENT OF COMMERCE IS RECONFIRMING PRIOR INSTRUCTIONS REGARDING THE ANTIDUMPING DUTY ORDER ON GRAY PORTLAND CEMENT AND CLINKER FROM MEXICO.

2. IN ACCORDANCE TO PRIOR INSTRUCTIONS, CUSTOMS SHOULD CONTINUE TO SUSPEND LIQUIDATION ON ALL IMPORTS OF CEMENT FROM CEMENTOS MEXICANOS, S.A. THIS SUSPENSION ALSO INCLUDES THE FOLLOWING SUBSIDIARIES: CEMENTOS DE CHIHUAHUA, S.A., CEMENTOS GUADALAJARA,

S.A., CEMENTOS PORTLAND NACIONAL, S.A., CEMENTOS ANAHUAC DEL GOLFO, S.A., CEMENTOS ANAHUAC DEL ATLANTICO, S.A., CEMENTOS ANAHUAC, S.A., CEMENTOS TOLTECA, S.A., AND CEMENTOS MAYA, S.A.. PLEASE NOTE THAT SOME OF THESE COMPANIES MIGHT ALSO BE DESIGNATED "S.A. DE. C.V." ON THE ENTRY DOCUMENTATION.

3. PLEASE NOTE THAT THESE COMPANIES ARE SUBSIDIARIES OF CEMENTOS MEXICANOS, S.A., AND SHOULD BE TREATED ACCORDINGLY.

4. CONTINUE TO SUSPEND LIQUIDATION OF CEMENT FROM CEMENTOS MEXICANOS, S.A., INCLUDING THE COMPANIES LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING GRAY PORTLAND CEMENT AND CLINKER FROM MEXICO.
