1. ON NOVEMBER 9, 1992, THE DEPARTMENT OF COMMERCE REINSTATED THE COUNTERVAILING DUTY ORDER ON CERTAIN TEXTILE MILL PRODUCTS FROM ARGENTINA (C-357-404) EFFECTIVE MAY 18, 1992.
2. THE MERCHANDISE COVERED BY THESE INSTRUCTIONS ARE TEXTILE MILL PRODUCTS FROM ARGENTINA CLASSIFIABLE UNDER THE HARMONIZED TARIFF SCHEDULE ITEM NUMBERS IN CIE N-206/84, SUPPL. 41, FEBRUARY 22, 1989, ON THE PAGE ENTITLED "CERTAIN TEXTILE MILL PRODUCTS - LIST 1."

3. THE SUSPENSION OF LIQUIDATION ORDERED IN THE JUNE 2, 1992 E-MAIL NO. 2154111 WILL CONTINUE. IN ACCORDANCE WITH THE COUNTERVAILING DUTY ORDER OF MARCH 12, 1985 YOU ARE TO COLLECT A CASH DEPOSIT OF 4.53 PERCENT ON ENTRIES OF THIS MERCHANDISE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER NOVEMBER 9, 1992.
