RE: LIQUIDATION INSTRUCTIONS ON STANDARD CHRYSANTHEMUMS FROM THE NETHERLANDS

1. THE DEPARTMENT OF COMMERCE DID NOT RECEIVE A REQUEST FOR AN ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON STANDARD CHRYSANTHEMUMS FROM THE NETHERLANDS FOR THE REVIEW PERIODS JANUARY 1, 1988 THROUGH DECEMBER 31, 1989. THEREFORE, RELEVANT ENTRIES ARE TO BE LIQUIDATED AT THE RATE OF CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES REQUIRED AT THE TIME OF ENTRY.

2. THE MERCHANDISE COVERED BY THESE INSTRUCTIONS ARE SHIPMENTS

OF STANDARD CHRYSANTHEMUMS FROM THE NETHERLANDS. DURING THE REVIEW PERIOD, SUCH MERCHANDISE WAS CLASSIFIABLE UNDER ITEM NUMBER 192.2120 OF TARIFF SCHEDULE OF THE UNITED STATES ANNOTATED. THIS MERCHANDISE IS CURRENTLY CLASSIFIABLE UNDER ITEM NUMBER 0603.10.70 OF THE HARMONIZED TARIFF SCHEDULE.

3. IN ACCORDANCE WITH SECTION 355.22(G) OF THE COMMERCE REGULATIONS, YOU ARE TO ASSESS COUNTERVAILING DUTIES AT A RATE EQUAL TO THE CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES REQUIRED AT THE TIME OF ENTRY ON MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1988 AND ON OR BEFORE DECEMBER 31, 1989.

4. THE RATE OF ESTIMATED COUNTERVAILING DUTIES WHICH WAS REQUIRED TO BE DEPOSITED IS:

5. THE SUSPENSION OF LIQUIDATION ORDERED FOR THIS MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1988 AND ON OR BEFORE DECEMBER 31, 1989 IS LIFTED. THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF THIS MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1992 WILL CONTINUE. LIQUIDATION INSTRUCTIONS FOR ALL INTERVENING PERIODS HAVE ALREADY BEEN ISSUED. YOU ARE TO CONTINUE TO COLLECT A CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES FOR ALL FIRMS AT THE CURRENT RATE OF ZERO PERCENT IN ACCORDANCE WITH OUR PREVIOUS INSTRUCTIONS ISSUED IN E-MAIL 2176113 OF 6/24/92. THIS DEPOSIT REQUIREMENT WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON THIS MERCHANDISE.

6. THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT REQUIRE THAT INTEREST BE PAID ON OVERPAYMENTS OR UNDERPAYMENTS OF AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. SUCH INTEREST

IS PAYABLE AT THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD. THE INTEREST SHALL BE CALCULATED AT THAT RATE FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION.
