COMPANY, LTD.

NOT LIQUIDATE ANY ENTRIES OF MMF SWEATERS OF JIA FARN MANUFACTURING COMPANY, LTD. WITH ENTRY DATES, ON OR AFTER APRIL 27, 1990.

3. EFFECTIVE NOVEMBER 27, 1992, FOR ENTRIES OF MMF SWEATERS EXPORTED OR PURPORTED TO BE MANUFACTURED BY JIA FARN MANUFACTURING COMPANY, LTD., THE CASH DEPOSIT RATE IN EFFECT IS THE "ALL OTHERS" RATE FROM THE ORIGINAL INVESTIGATION, 21.3 PERCENT.
