1. THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER
ON JULY 24, 1992, NOTICE OF INITIATION OF COUNTERVAILING DUTY
INVESTIGATIONS AND NOTICE OF POSTPONEMENT OF PRELIMINARY
DETERMINATIONS REGARDING CERTAIN STEEL PRODUCTS FROM SPAIN.

2. THE PRODUCTS COVERED BY THESE INVESTIGATIONS, CERTAIN
FLAT-ROLLED STEEL PRODUCTS, CONSTITUTE THE FOLLOWING TWO SEPARATE

OUR WRITTEN DESCRIPTIONS OF THE SCOPE OF THESE PROCEEDINGS ARE DISPOSITIVE.

CERTAIN COLD-ROLLED CARBON STEEL FLAT PRODUCTS:

THESE PRODUCTS INCLUDE COLD-ROLLED (COLD-REDUCED) CARBON STEEL FLAT PRODUCTS, OF SOLID RECTANGULAR (OTHER THAN SQUARE) CROSS SECTION, OF RECTANGULAR SHAPE, NEITHER CLAD, PLATED NOR COATED WITH METAL, WHETHER OR NOT PAINTED, VARNISHED OR COATED WITH PLASTICS OR OTHER NONMETALLIC SUBSTANCES, IN COILS, OR IN STRAIGHT LENGTHS WHICH, IF OF A THICKNESS LESS THAN 4.75 MILLIMETERS, ARE OF A WIDTH MEASURING AT LEAST 10 TIMES THE THICKNESS OR IF OF A THICKNESS OF 4.75 MILLIMETERS OR MORE ARE OF A WIDTH WHICH EXCEEDS 150 MILLIMETERS AND MEASURES AT LEAST TWICE THE THICKNESS, AS CURRENTLY CLASSIFIABLE IN THE HTS UNDER ITEM NUMBERS:

SOLID RECTANGULAR (OTHER THAN SQUARE) CROSS SECTION, OF RECTANGULAR SHAPE, NEITHER CLAD, PLATED NOR COATED WITH METAL, WHETHER OR NOT PAINTED, VARNISHED, OR COATED WITH PLASTICS OR OTHER NONMETALLIC SUBSTANCES; AND CERTAIN HOT-ROLLED CARBON STEEL
