ON 12/19/2003, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION (CIT CASE # 03-00872) ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER OR FINDING ON CERTAIN POLYESTER STAPLE FIBER FROM KOREA (A-580-839), ENTERED BY, THROUGH, OR ON BEHALF OF CONSOLIDATED TEXTILES, INC. ("CONSOLIDATED TEXTILES") COMMENCING 05/01/2002.

2. ACCORDINGLY EFFECTIVE 12/19/2003, UNTIL FURTHER NOTICE, DO

NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS ENTERED BY, THROUGH, OR ON BEHALF OF CONSOLIDATED TEXTILES AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD COMMENCING 05/01/2002 AND REMAIN UNLIQUIDATED AS OF DECEMBER 19, 2003. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
