OF CERTAIN STEEL PRODUCTS FROM SWEDEN

1. THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER ON DECEMBER 7, 1992, NOTICE OF ITS PRELIMINARY DETERMINATION THAT CERTAIN BENEFITS WHICH CONSTITUTE SUBSIDIES WITHIN THE MEANING OF THE COUNTERVAILING DUTY LAW ARE BEING PROVIDED TO THE PRODUCERS, MANUFACTURERS, OR EXPORTERS OF CERTAIN STEEL PRODUCTS FROM SWEDEN.

2. THE PRODUCTS COVERED BY THESE INVESTIGATIONS, CERTAIN STEEL PRODUCTS. CONSTITUTE THE TWO SEPARATE "CLASSES OR KINDS" OF

MERCHANDISE OUTLINED BELOW. ALTHOUGH THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTS) SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, OUR WRITTEN DESCRIPTION OF THE SCOPE OF THIS PROCEEDING IS DISPOSITIVE.

CERTAIN CORROSION-RESISTANT CARBON STEEL FLAT PRODUCTS:

THESE PRODUCTS INCLUDE FLAT-ROLLED CARBON STEEL PRODUCTS OF SOLID RECTANGULAR (OTHER THAN SQUARE) CROSS SECTION, OF RECTANGULAR SHAPE, EITHER CLAD, PLATED, OR COATED WITH CORROSION-RESISTANT METALS SUCH AS ZINC, ALUMINUM, OR ZINC-, ALUMINUM-, NICKEL-, OR IRON-BASED ALLOYS, WHETHER OR NOT CORRUGATED OR PAINTED, VARNISHED OR COATED WITH PLASTICS OR OTHER NONMETALLIC SUBSTANCES

IN ADDITION TO THE METALLIC COATING, IN COIL, OR IN STRAIGHT LENGTHS WHICH, IF OF A THICKNESS LESS THAN 4.75 MILLIMETERS, ARE OF A WIDTH MEASURING AT LEAST 10 TIMES THE THICKNESS OR IF OF A THICKNESS OF 4.75 MILLIMETERS OR MORE ARE OF A WIDTH WHICH EXCEEDS 150 MILLIMETERS AND MEASURES AT LEAST TWICE THE THICKNESS, AS CURRENTLY CLASSIFIABLE IN THE HTS UNTER ITEM NUMBERS 7210.31.0000, 7210.39.0000, 7210.41.0000, 7210.49.0030, 7210.49.0090, 7210.60.0000, 7210.70.6030, 7210.70.6060, 7210.70.6090, 7210.90.1000, 7210.90.6000, 7210.90.9000, 7212.21.0000, 7212.29.0000, 7212.30.1030, 7212.30.1090, 7212.30.3000, 7212.30.5000, 7212.40.1000, 7212.40.5000, 7212.50.0000, AND 7212.60.0000. EXCLUDED FROM THESE INVESTIGATIONS ARE FLAT-ROLLED STEEL PRODUCTS EITHER PLATED OR COATED WITH TIN, LEAD, CHROMIUM, CHROMIUM OXIDES, BOTH TIN AND LEAD ("TERNE PLATE"), OR BOTH CHROMIUM AND CHROMIUM OXIDES ("TIN-FREE STEEL").

CERTAIN CUT-TO-LENGTH CARBON STEEL PLATE:

THESE PRODUCTS INCLUDE HOT-ROLLED CARBON STEEL UNIVERSAL MILL PLATES (I.E ., FLAT-ROLLED PRODUCTS ROLLED ON FOUR FACES OR IN A CLOSED BOX PASS, OF A WIDTH EXCEEDING 150 MILLIMETERS BUT NOT EXCEEDING 1.250 MILLIMETERS AND OF A THICKNESS OF NOT LESS THAN 4 MILLIMETERS, NOT IN COILS AND WITHOUT PATTERNS IN RELIEF) OF SOLID RECTANGULAR (OTHER THAN SQUARE) CROSS SECTION, OF RECTANGULAR SHAPE, NEITHER CLAD, PLATED NOR COATED WITH METAL, WHETHER OR NOT PAINTED, VARNISHED, OR COATED WITH PLASTICS OR OTHER NONMETALLIC SUBSTANCES: AND CERTAIN HOT-ROLLED CARBON STEEL

FLAT PRODUCTS IN STRAIGHT LENGTHS, OF SOLID RECTANGULAR (OTHER THAN SQUARE) CROSS SECTION, OF RECTANGULAR SHAPE, HOT ROLLED NEITHER CLAD PLATED, NOR COATED WITH METAL, WHETHER OR NOT PAINTED, VARNISHED, OR COATED WITH PLASTICS OF OTHER NONMETALLIC SUBSTANCES, 4.75 MILLIMETERS OR MORE IN THICKNESS AND OF A WIDTH WHICH EXCEEDS 150 MILLIMETERS AND MEASURES AT LEAST TWICE THE THICKNESS, AS CURRENTLY CLASSIFIABLE IN THE HTS UNDER ITEM NUMBERS 7208.31.0000, 7208.32.0000, 7208.33.1000, 7208.33.5000, 7208.41.0000, 7208.42.0000, 7208.43.0000, 7208.90.0000, 7210.70.3000, 7210.90.9000, 7211.11.0000, 7211.12.0000, 7211.21.0000, 7211.22.0045, 7211.90.0000, 7212.40.1000, 7212.40.5000, AND 7212.50.0000.

3. THE U.S. CUSTOMS SERVICE SHALL SUSPEND LIQUIDATION OF ALL ENTRIES OF CERTAIN STEEL PRODUCTS FROM SWEDEN WHICH ARE ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER DECEMBER 7, 1992, AND SHALL REQUIRE A CASH DEPOSIT OR BOND FOR SUCH ENTRIES OF THE MERCHANDISE AS FOLLOWS:

THE CASE NUMBER ENCOMPASSES THE TWO CLASSES OR KINDS OF MERCHANDISE UNDER INVESTIGATION. FOR CUSTOMS REPORTING PURPOSES EACH CLASS OR KIND HAS BEEN ASSIGNED A SEPARATE CASE NUMBER: CORROSION-RESISTANT (C-401-208) AND PLATE (C-401-209).

ENTRIES REJECTED FOR THIS REASON SHOULD BE RE-SUBMITTED ON DECEMBER 14, 1992. LATE- FILE PENALTIES DUE TO THESE SYSTEM REJECTS WILL BE WAIVED.
