1. THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW OF THE ANTIDUMPING DUTY ORDER ON RED RASPBERRIES FROM CANADA (A-122-401) FOR THE JUNE 1, 1990 TO MAY 3, 1991 PERIOD AND PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON NOVEMBER 3, 1992 (57 FR 49686).

2. IMPORTS COVERED BY THIS REVIEW ARE FRESH AND FROZEN RED RASPBERRIES PACKED IN BULK CONTAINERS AND SUITABLE FOR FURTHER PROCESSING. DURING THE REVIEW PERIOD, SUCH

MERCHANDISE WAS CLASSIFIABLE UNDER HARMONIZED TARIFF SCHEDULE
ITEM NUMBERS 0810.20.90, 0810.20.10 AND 0811.20.20.

3. ACCORDINGLY, FOR SHIPMENTS OF RED RASPBERRIES FROM CANADA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER NOVEMBER 3, 1992, THE FOLLOWING CASH DEPOSITS ARE REQUIRED FOR THE REVIEWED EXPORTERS:

BLUEBERRY AFTER PUBLICATION OF THE FINAL RESULTS OF REVIEW IN THE FEDERAL REGISTER ON NOVEMBER 3, 1992 (57 FR 49686).

THE CASH DEPOSIT FOR OTHER PREVIOUSLY REVIEWED OR INVESTIGATED COMPANIES IS THEIR RATE PROVIDED IN THE AD/CVD MODULE. FOR ALL OTHER MANUFACTURERS OR EXPORTERS, THE CASH DEPOSIT REQUIRED IS ZERO.

4. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW.
5. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL APPRAISEMENT INSTRUCTIONS ARE ISSUED. INSTRUCTIONS WILL NOT BE SENT UNTIL AT LEAST 30 DAYS AFTER PUBLICATION OF THE FINAL RESULTS, AND MAY BE DELAYED

INDEFINITELY IF AN APPEAL OF THE FINAL RESULTS IS FILED WITH THE U.S. CANADA BINATIONAL PANEL.
