PURSUANT TO SECTION 129(b)(4) OF THE URAA, THE U.S. TRADE REPRESENTATIVE (USTR) NOTIFIED THE DEPARTMENT OF COMMERCE (THE DEPARTMENT) ON 11/07/2003 AND REQUESTED THE IMPLEMENTATION OF THE DEPARTMENT'S SECTION 129 DETERMINATION WITH RESPECT TO CERTAIN CUT-TO-LENGTH CARBON STEEL PLATE FROM SWEDEN (C-401-109).

2. PURSUANT TO SECTION 129(c)(1)(B) OF THE URAA, THE DEPARTMENT IS IMPLEMENTING ITS SECTION 129 DETERMINATION WITH REGARD TO

SVENSKT STAL'S (SSAB) (C-401-109-001) EXPORTS OF CERTAIN CUT-TO-LENGTH CARBON STEEL PLATE FROM SWEDEN (C-401-109). THIS NOTICE OF IMPLEMENTATION UNDER SECTION 129 WAS PUBLISHED ON 11/07/2003 IN THE FEDERAL REGISTER (68 FR 64858). ACCORDINGLY, FOR SSAB'S SHIPMENTS OF SUBJECT MERCHANDISE FROM SWEDEN ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 11/07/2003, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED TO ZERO PERCENT.

3. THIS CASH DEPOSIT RATE FOR SSAB WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES OF SUBJECT MERCHANDISE FROM SSAB UNTIL LIQUIDATION INSTRUCTIONS ARE RECEIVED.
