ON OCTOBER 24, 2003, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER OR FINDING ON STAINLESS STEEL FLANGES FROM INDIA (A-533-809), MANUFACTURED OR EXPORTED BY ECHJAY FORGINGS PVT. LTD. FOR THE PERIOD 02/01/2001 THROUGH 01/31/2002.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS MANUFACTURED OR EXPORTED BY ECHJAY

FORGINGS PVT. LTD. AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 02/01/2001 THROUGH 01/31/2002 AND REMAIN UNLIQUIDATED AS OF 5PM ON NOVEMBER 18, 2003. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
