1. THE DEPARTMENT OF COMMERCE DID NOT RECEIVE A REQUEST FOR AN ADMINISTRATIVE REVIEW OF THE FOLLOWING COUNTERVAILING DUTY ORDERS FOR THE REVIEW PERIODS LISTED BELOW.
2. THE COUNTERVAILING DUTY ORDERS AND CORRESPONDING SUBJECT MERCHANDISE COVERED BY THESE INSTRUCTIONS ARE AS FOLLOWS:

CERTAIN STEEL WIRE NAILS FROM THAILAND INCLUDING ONE PIECE  
ROUND WIRE, TWO-PIECE ROUND WIRE, STEEL WIRE SHANKS AND LEAD

HEADS. SUCH MERCHANDISE IS CLASSIFIABLE UNDER HTS ITEM NUMBER 7317.00.55.

CERTAIN STEEL WIRE NAILS FROM NEW ZEALAND INCLUDING ONE PIECE ROUND WIRE, TWO-PIECE ROUND WIRE, STEEL WIRE SHANKS AND LEAD HEADS. SUCH MERCHANDISE IS CLASSIFIABLE UNDER HTS ITEM NUMBERS 7317.00.55, 7317.00.65, AND 7317.00.75.

CERTAIN ROASTED IN-SHELL PISTACHIO NUTS, WHETHER ROASTED IN IRAN OR ELSEWHERE, FROM WHICH THE HULLS HAS BEEN REMOVED, LEAVING THE INNER HARD SHELLS AND THE EDIBLE MEAT. SUCH MERCHANDISE IS CLASSIFIABLE UNDER HTS ITEM NUMBER 2008.19.30.

3. THEREFORE, IN ACCORDANCE WITH SECTION 355.22(G) OF THE COMMERCE REGULATIONS, YOU ARE TO ASSESS COUNTERVAILING DUTIES AT RATES EQUAL TO THE CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES REQUIRED AT THE TIME OF ENTRY ON MERCHANDISE EXPORTED ON OR AFTER JANUARY 1, 1990 AND ON OR BEFORE DECEMBER 31, 1990 FOR PISTACHIOS FROM IRAN, AND ON OR AFTER JANUARY 1, 1991 AND ON OR BEFORE DECEMBER 31, 1991 FOR THE OTHER CASES.

5. THE SUSPENSION OF LIQUIDATION ORDERED FOR IRANIAN PISTACHIOS EXPORTEDS ON OR AFTER JANUARY 1, 1990 AND ON OR BEFORE DECEMBER 31, 1990 IS LIFTED. THE SUSPENSION OF LIQUIDATION ORDERED FOR THE OTHER MERCHANDISE LISTED ABOVE EXPORTED ON OR AFTER JANUARY 1, 1991 AND ON OR BEFORE DECEMBER 31, 1991 IS ALSO LIFTED. ENTRIES OF IRANIAN PISTACHIOS FOR THE 1991 PERIOD WERE LIQUIDATED PER EMAIL INSTRUCTIONS 2155113 OF JUNE 3, 1992. THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF THE MERCHANDISE LISTED ABOVE EXPORTED AFTER DECEMBER 31, 1991 WILL CONTINUE.
6. THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT REQUIRE THAT INTEREST BE PAID ON OVERPAYMENTS OR UNDERPAYMENTS OF AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. SUCH INTEREST IS PAYABLE AT THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD. THE INTEREST SHALL BE CALCULATED AT THAT RATE FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION.
