ON 11/09/1999, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE COUNTERVAILING DUTY ORDER OR FINDING ON STAINLESS STEEL SHEET AND STRIP IN COILS FROM ITALY (C-475-825), MANUFACTURED AND/OR EXPORTED BY ACCIAI SPECIALI TERNI S.P.A. ("AST"), C-475-825-001, FOR THE PERIOD 11/17/1998 THROUGH 03/16/1999.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS MANUFACTURED OR EXPORTED BY AST

AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 11/17/1998 THROUGH 03/16/1999 AND REMAIN UNLIQUIDATED AS OF 5 O'CLOCK P.M. ON AUGUST 30, 2000. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE SENT. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
