RE: FINAL SCOPE RULING ON ANTIFRICTION BEARINGS (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM GERMANY - EICH COMPANY (091892 IS FED REG PUBLICATION DATE)

1. ON SEPTEMBER 18, 1992, IN RESPONSE TO A REQUEST BY TIMCO, INC., THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT FLEXIBLE ROLLER BEARING MODELS 526, 2236, AND 1254, WHICH ARE MANUFACTURED BY THE EICH COMPANY AND IMPORTED BY TIMCO, ARE NEEDLE ROLLER BEARINGS THAT ARE EXCLUDED FROM THE SCOPE OF THE ANTIDUMPING DUTY ORDERS ON ANTIFRICTION BEARINGS FROM GERMANY. THE DEPARTMENT DETERMINED THAT THESE BEARINGS ARE NEEDLE ROLLER BEARINGS BECAUSE THE COMPONENT ROLLERS OF THESE

BEARINGS HAVE A LENGTH-TO-DIAMETER RATIO OF GREATER THAN 4:1, WHICH IS THE STANDARD THE DEPARTMENT HAS ADOPTED IN DISTINGUISHING NEEDLE ROLLER BEARINGS FROM CYLINDRICAL ROLLER BEARINGS.

2. EFFECTIVE IMMEDIATELY, TERMINATE SUSPENSION AND LIQUIDATE WITHOUT REGARD TO ANTIDUMPING DUTIES ALL UNLIQUIDATED ENTRIES, REGARDLESS OF ENTRY DATE, OF THE PRODUCTS LISTED ABOVE.
3. REFUND ANY CASH DEPOSITS AND RELEASE ANY BONDS RELATING TO THE ABOVE-LISTED PRODUCTS.
4. FURTHER, THE DEPARTMENT DETERMINED THAT EICH FLEXIBLE ROLLER BEARING MODELS 015 AND 1255 ARE CYLINDRICAL ROLLER BEARINGS THAT REMAIN SUBJECT TO THE ORDER. THE DEPARTMENT DETERMINED THAT THESE BEARINGS ARE CYLINDRICAL ROLLER BEARINGS BECAUSE THE COMPONENT ROLLERS OF THESE BEARINGS HAVE A LENGTH-TO-DIAMETER RATIO OF LESS THAN 4:1.
5. CONTINUE TO SUSPEND LIQUIDATION OF ALL ENTRIES OF THE PRODUCTS LISTED IN PARAGRAPH 4 ABOVE, AND REQUIRE A CASH DEPOSIT OF ESTIMATED ANTIDUMPING DUTIES AT THE APPLICABLE RATE.
