ON 12/22/1999, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE COUNTERVAILING DUTY ORDER OR FINDING ON STAINLESS STEEL SHEET AND STRIP IN COILS FROM FRANCE (C - 427-815) MANUFACTURED AND/OR EXPORTED BY USINOR, UGINE S.A., AND UGINOX SALES CORPORATION FOR THE PERIOD 11/17/1998 THROUGH 03/16/1999.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES

OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND/OR EXPORTED BY USINOR, UGINE S.A., AND UGINOX SALES CORPORATION C-427-815-001, AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 11/17/1998 THROUGH 03/16/1999, AND WHICH REMAIN UNLIQUIDATED AS OF JANUARY 20, 2000, THE DATE THE INJUNCTION WAS SERVED ON CBP AND THE DEPARTMENT. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
